

OM HOMEOPATHY FEES 2021
FEES AND POLICIES FOR CONSULTATION

- **Initial Homeopathic consultation – \$200**

The initial consultation usually takes between 90 min to 2.5 hours and takes place in person, via Skype, Face-time, or by telemedicine's web services.

Since the aim is to understand each person as an individual, a detailed history is taken including emotions, feelings and at times can also go back to the childhood and even in cases of kids to the pregnancy and emotions of the mother.

- **Follow-ups – \$100**

The follow-up consults usually take 30 to 60 min. The cost of the follow-up care includes unlimited e-mails, continuous case management, questions, drafting and revising homeopathic protocols. Scheduled brief phone calls are included in the follow-up care fee.

- **Acute consultation – \$60**

Acute consultations are available seven days a week for short-term non-life threatening illnesses such as: fever, diarrhoea, nausea, vomiting, cold, flu, sore throat, cough, ear infections, Urine infections, teething, etc.

It is highly recommended that clients have a remedy kit in the household. Fee is for up to 1 week.

- **Packages- 3 / 6 / 12 Months**

For chronic and complicated health conditions like allergies, asthma, autism, cancers, psychological issues like depression, anxiety, Lyme disease, it is advisable to go with packages. All packages include first session, all follow ups and all acutes during that time frame. Due at the first session.

- **3 Months - \$450**
- **6 Months - \$700**
- **Yearly - \$1500**
- **Monthly Payment Plan - \$150**

- **Ayurvedic Nutrition Consultation- \$200**

You will be asked to maintain a food diary/ journal for min 3 Days. There are few questioners you need to answer and your Dosha, your vikruti (disease) will be evaluated and an individualized diet plan, lists of food to avoid and food to favor will be given to you along with some recipes. All details will be emailed and one session will be scheduled to discuss and Q/A about the plan.

- **Mindfulness Meditation - 8 weeks program - \$250**

- **Other holistic modalities (Complimentary)**

I incorporate flower remedies, Mudras, cell salts, gemmotherapy along with homeopathic consultations in my treatment plans. I don't charge separately for them.

General Policies Regarding Fees, Payment, Scheduling and Shipping:

- Fees are due at the time services are rendered.
- Fee is non refundable.
- Payments may be made by Credit cards, HSA/ FSA cards, **If paying by cards a 3.5% processing fee will be added.**
- Other options of payments are Check, Venmo, online bank to bank transfer thru Zelle.

- Clients are free to discontinue treatment at any time without penalty.
- If you have scheduled a remote consultation, please pay online or mail a check in advance of the appointment so that I receive it before the appointment.

- **Medicines and Shipping:**

Medicines will be shipped to the clients at the address provided. Cost of medicines is variable depending upon the potency, dose of the medicine, and pharmacy selected. This cost is not included in consultation fees. Usually 1 homeopathic medicines may cost from \$10- \$16 and \$10- 20 for one flower remedy bottle for a months supply. Shipping is \$5 to \$15 in USA.

Insurance:

It is client's responsibility to check with their insurance provider whether homeopathic consultations are covered in their plan or not. Clients are encouraged to investigate their healthcare plan as it may allow coverage for natural therapies and homeopathic care/ medicines.

Cancellations:

If it is necessary to cancel and/or reschedule an appointment, notification must be made at least 24 hours in advance. Missed or late cancellation appointments will result in a 50% fee of the cost of your session.

Contacting other than appointments:

- Clients can email for reports, updates, questions, scheduling, and other non-urgent topic. Calls are generally answered each day; emails are answered as time allows which can be delayed during times of travel or high volume of email.
